Elementary Athletic Policy 2021-2022

The General Purposes of St. Ann's Academy Elementary Athletics Program are:

- To promote and enhance the identity of St. Ann's Academy in the community, city, and province.
- To provide the opportunity for an athlete to compete in a level of competition that promotes athletic excellence and the enhancement of their God-given talents.
- To encourage pride and a healthy school spirit in the student population.
- To afford a unique and valuable experience for students and teachers (coach) by which they relate to one another in a non-academic environment. It has been proven that these types of experiences not only offer an excellent opportunity for character building but often have a positive effect on a student's academic performance.

Student Expectations:

- Athletes must be in attendance at school on a game or practice day or will not be able to participate in the scheduled event.
- A coach must be consulted ahead of time if any athlete must miss a practice or game. Missing games or practices without permission may result in suspension or expulsion from the team.
- Athletes must demonstrate fair play and sportsmanship at all times.
- Athletes must show respect for teammates, opponents, officials, coaches and school property.
- Athletes' participation in extracurricular athletics is contingent on student-athletes adhering to school expectations in terms of behaviour and school work.

CODE OF ETHICS FOR ST. ANN'S ACADEMY ATHLETIC PROGRAM

1) Commitment

Each team member is expected to attend all practices and games. Schedule conflicts must be discussed with the coach in advance. If there are continued absences, further participation on the team will have to be discussed. Lunchtime practices are mandatory so each athlete is responsible for knowing their schedule.

2) Sportsmanship

St. Ann's Academy athletes and coaches are expected to maintain the highest of standards. Respect for opponents and officials is of the utmost importance in our programs. Athletes unable to follow the athletic code will have a meeting with the coach and Athletic Director in which suspension from the program for one or more games or possibly the season will be discussed. In serious offences, a suspension could be for the entire year from the Elementary Athletic Program.

3) Service

Participating athletes are expected to help out with the program in the form of scorekeeping, concessions or other areas when reasonably requested if applicable.

4) **Citizenship**

High standards of behavior and attitude are required. School rules apply to all events. Poor behaviour choices can result in disciplinary action and suspension from athletics. This will result in a suspension from a game, week, season of play, or year from the athletic Department.

5) **Academics**

Each student-athlete is expected to maintain ACADEMIC and EFFORT standards consistent with his/her ability. If these standards are not maintained the student may receive a game suspension. If there is no improvement upon a meeting with the Athletic Director and classroom teacher, the suspension may continue for a week or for the entire season of play. Regular class attendance is mandatory. **If a student is unable to attend school on the day of a scheduled game, the student will not be allowed to play in the game that day.**

6) **Fees**

A non-refundable **\$20 fee per sport** will be collected before each season to help offset the costs of running the Athletic Department. This fee will cover busing and referee expenses, and other costs associated with the elementary athletics program. The payment needs to be paid by the first league game/event of the season or the athlete will not be allowed to participate in that game.

7) **Uniforms**

Uniforms and equipment are the property of St. Ann's Academy and must be cared for. If lost or damaged, charges will be levied. Because uniforms are so expensive, a \$100.00 deposit is required before a uniform can be distributed. This cheque will not be cashed unless a uniform is lost or not returned. You will be informed before your cheque is cashed. Please communicate to your child the responsibility that comes with being assigned a school athletics uniform. Uniforms must be returned no later than 7 days after the final contest of the season.

7) **Parents**

Attendance at school-organized athletic events (both on and off school grounds) is encouraged and recognized as a key element in a student's elementary school experience. This privilege may be withdrawn if school staff or even officials have reasonable grounds to suspect that the safety/well-being of fellow students, opposing players, game officials, or any other person at the event are compromised.

Parents/ family who attend events therefore shall:

- Model our faith as supporters of St. Ann's Academy athletic program.
- Not have unrealistic expectations and will understand that doing one's best is as important as winning.
- Respect the official's decisions and will encourage all participants to do the same.
- Respect and show appreciation for the coaches and understand that they have given their time to provide sport activities for our young people.
- Encourage athletes and coaches to play by the rules and to resolve conflicts without resorting to hostility or violence.
- Show respect for SAA's opponents because I realize there would be no game without them.
- Not use bad language and will not harass athletes, coaches, officials, or other spectators

Credit Card, E-transfers and debit payments can be made at the school office. **Please do not combine the \$20 and the \$100 on one cheque.** Please review policy information carefully before signing this document. *Both student-athletes and parents need to review and sign the Elementary Athletic form.*

IF AN ATHLETE JEOPARDIZES HIS/HER PRIVILEGE OF BEING ON A SCHOOL TEAM, A MEETING WILL TAKE PLACE WITH THE ATHLETE, COACH AND RESPECTIVE STAFF MEMBER. FINAL DECISIONS REGARDING AN ATHLETE'S STATUS ON A TEAM WILL BE MADE IN CONSULTATION WITH THE ATHLETIC DIRECTOR AND VICE PRINCIPAL IN CHARGE.
